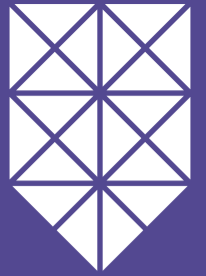

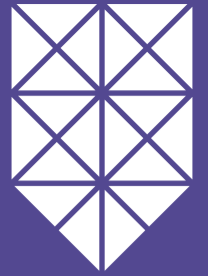

Temporary Residence visas:

Visa must have a minimum of 1 year before expiration at the time of applying for personal loan, i.e. "Length of stay" on visa document must be greater than 12 months from application date for personal loan.

If personal loan application is for a Fixed Rate loan, then the personal loan term/duration/time to repay must expire 6 months before expiration of Temporary Residence visa.
